A. ROLL CALL

Mayor Hannon called the meeting to order at 7:15 p.m. Vice Mayor Freitas and Council Member Jorgens were present.

City Attorney Kokotaylo announced that Council Member Collazo requested to participate in the meeting remotely based on an emergency medical need. Per Assembly Bill 2449 the City Council would need to vote on whether to allow Council Member Collazo to participate in the meeting.

Vice Mayor Freitas moved, Council Member Jorgens seconded to allow Council Member Collazo to participate in the meeting via Zoom. The motion passed, 3 AYES.

Council Member Collazo joined the meeting via Zoom.

Mayor Hannon announced that because Council Member Collazo was attending the meeting via Zoom, the webinar would be activated to allow the public to participate via Zoom.

Mayor Hannon announced that Council Member Bucci resigned from the City Council and that the City Council voted at a special meeting to open an application period from June 28 to July 7 for the vacancy until the election. The Council will meet on July 8th to consider the applications.

Mayor Hannon announced that he would consider item F.1 first to allow Council Member Collazo to participate in the decision-making process.

F.1 Consider for adoption a resolution calling an election to be held on November 5, 2024, for voter consideration of a ballot measure seeking voter authorization to amend Municipal Code Chapter 3.16 to increase the City's existing transient occupancy (hotel) tax; establishing policies and procedures in connection with such an election; requesting the Board of Supervisors of the County of Alameda to consolidate the general municipal election with the general election to be held on November 5, 2024; requesting certain services of the Registrar of Voters of Alameda County with respect to the consolidated general municipal election; and providing for submittal of ballot arguments and rebuttals and authorizing the filing of an impartial analysis Resolution No. 11650

City Manager Benoun stated that the City has a 10% Transient Occupancy (Hotel) Tax, that provides funding for services. He stated that funding was needed for the replacement of fire stations, maintenance needs, and to implement the various Master Plans. If a 4% hotel tax increase was approved by the voters, it would increase the tax by \$2.1 million annually. He reviewed the steps to place this proposed increase on the November 5, 2024 election. Presentation on file with the City Clerk.

No one from the public requested to speak

Council Member Collazo stated this tax would only apply to visitors using Newark hotels.

City Manager Benoun stated that due to technical issues, the clean version of the proposed ordinance was included in the packet and the proposed redlines ordinance should be included in the motion.

Council Member Jorgens moved, Council Member Collazo seconded to Call an Election To Be Held On November 5, 2024, For Voter Consideration Of A Ballot Measure Seeking Voter Authorization To Amend Municipal Code Chapter 3.16 To Increase The City's Existing Transient Occupancy (Hotel) Tax; Establishing Policies And Procedures In Connection With Such An Election; Requesting The Board Of Supervisors Of The County Of Alameda To Consolidate The General Municipal Election With The General Election To Be Held On November 5, 2024;

Requesting Certain Services Of The Registrar Of Voters Of Alameda County With Respect To The Consolidated General Municipal Election; And Providing For Submittal Of Ballot Arguments And Rebuttals And Authorizing The Filing Of An Impartial Analysis, with the redlined version of the ordinance. The motion passed, 4 AYES.

Council Member Collazo thanked everyone for their well wishes. She wished everyone a safe and happy Fourth of July. Shop Newark.

Council Member Collazo exited the meeting at 7:42 pm.

Fario Martinez requested that the City Council ban all flavored tobacco products, and make tobacco products more expensive to discourage use.

City Manager Benoun stated that staff will have a recommendation for the City Council in September.

Senior Planner Lopez stated that the City's development impact fees adjustments are on an annual basis based on the Engineering News Record Construction Cost Index for San Francisco. Based on the May 2024 Index, the development impact fees must be decreased by 1.1%.

Mayor Hannon opened the public hearing at 8:04 p.m.

Mayor Hannon closed the public hearing at 8:05 p.m.

Moved by Council Member Jorgens, seconded by Mayor Hannon, to adopt the resolution. The motion passed 3 AYES, 1 ABSENT.

Moved by Council Member Jorgens, seconded by Vice Mayor Freitas to adopt the resolution. The motion passed 3 AYES, 1 ABSENT

Mayor Hannon called for a recess at 8:17 p.m. The meeting resumed at 8:25 p.m.

Police Lieutenant Simon stated that Assembly Bill 481 requires the Police Department to provide a Military Equipment annual report and for the City Council to vote on the renewal annually. He gave the annual presentation. Presentation on file with City Clerk

2. Presentation of final designs for Citywide Parks Signage Program, Project 1272

Junior Engineer Reyes shared the revised citywide parks signage design based on the City Council's comments at the previous meeting with the placement of the city logo, the enlarged font for "City of Newark", and the incorporation date of the park. She also shared the consultants revised design with the city logo in Blue in the concrete base. Presentation on file with the City Clerk

The City Council discussed the revised designs.

In response to Vice Mayor Freitas, Dickson Kaiser, GNU Group stated that with proper care, the sign color should be durable.

Jason Miguel asked if the City considered using local artists to create designs that would deter graffiti.

Mayor Hannon stated that the City Council was seeking uniformity in the park signs.

Mayor Hannon moved, Council Member Jorgens seconded to approve the consultants recommended design. The motion passed, 3 AYES, 1 ABSENT.

In response to City Council requests, City Manager Benoun stated the placement of the signs, the proposed text for the history of the parks, and park

names could be considered in the Fall.

G. CITY COUNCIL MATTERS

Council Member Jorgens requested public comment on the City's Active Transportation Plan on the city website. He stated this was a sad day with Council Member Bucci's resignation and he thought the City Council was better with him on it.

Vice Mayor Freitas stated that he was happy to see Council Member Collazo on Zoom. The design for the Central Avenue Overpass project update is 90% complete. He complimented the Recreation and Community Services Department for the Juneteenth event. He wished everyone a Safe and Sane Fourth of July.

Mayor Hannon thanked Council Member Bucci for his service to the community.

Mayor Hannon stated that he would adjourn the meeting in memory of Denise Fullerton.
