A. ROLL CALL

Mayor Hannon called the meeting to order at 7:05 p.m. Council Members Jorgens and Apodaca were present. Vice Mayor Freitas and Council Member Collazo were noted absent.

B. PRESENTATIONS

Mayor Hannon called for a recess at 7:32 p.m. The meeting resumed at 7:38 p.m.

c. PUBLIC COMMENT

Robert Thomas announced the Solid Rock Community Services Annual Health and Back to School Fair to be held on August 3.

Jacinta Arteaga congratulated Council Member Apodaca on her appointment. She thanked Council Member Collazo and Edda Rivera for their work on the Mariachi Festival and hoped there would be continued support.

Mayor Hannon stated that the Mariachi Festival was well attended and would continue in the future.

Mary Bonilla expressed her displeasure with the maintenance of Landscaping and Lighting District No. 11. She requested that the vote be tabled in order to reconsider the budget.

Han Lambruschini and Harita Veereshlingam requested City assistance to discourage drivers from speeding through their neighborhood. City Manager Benoun referred them to staff members in the audience.

Mayor Hannon requested a breakdown of the types of crimes that were not prosecuted by the District Attorney in future presentations.

Chief of Police Arguello stated that he anticipated the SRO would be filled in the fall and would include the requested information in future presentations.
