# A. PLEDGE OF ALLEGIANCE/ROLL CALL

#### B. MINUTES APPROVAL

#### C. WELCOME/INTRODUCTION

Chairperson Al Nagy welcomed Fremont Senior Citizen Commissioners Pat Helton, JoAnne Rhoades-Jones, and guest speaker Jimmy Isch from Second Chance.

# D. GUEST SPEAKER JIMMY ISCH - Program Coordinator from Second Chance, Inc.

Mr. Isch provided an overviewed of the wonderful programs and services provided by the dedicated staff and volunteers with Second Chance, Inc. Second Chance has numerous treatment and recovery programs available to those struggling with drug and alcohol addictions. Their stated purpose is to help people overcome their addictions in a supportive and caring environment. Second Chance, Inc. services are certified by the State of California.

#### E. HUMAN SERVICES/SENIOR CENTER STAFF REPORT

Recreation and Community Services Director David Zehnder distributed and reviewed with the committee a detailed report for the month of February, 2016.

Overall daily and program attendance for the month was 2,113 with no new Senior Case Management cases opened. An average of ten (10) daily meals were served at the Senior Center and Meals on Wheel delivered an average of 48 daily meals. Volunteers clocked 375 hours of service for the month.

Paratransit program service figures from January - February 2016 were not available.

#### F. OLD BUSINESS

Follow up on Automatic ADA Accessible Doors for the Silliman Aquatic Center.

Chairperson Al Nagy informed the committee that Ms. Mary Campbell's request for an automatic door system for the Silliman Aquatic Center was being reviewed as part of the annual Capital Improvement Plan (CIP). Final approval of all CIP projects will be addressed during the City Council budget work session in May.
