В. **MINUTES APPROVAL**

Minutes of the May 5, 2016 Senior Advisory Committee meeting were moved for approval by Senior Advisory Committee Member Faye Hall and seconded by Senior Advisory Committee Member Rick Arellano with all in favor.

C. WELCOME/INTRODUCTION

Chairperson Al Nagy welcomed Fremont Senior Citizen Commissioners JoAnne Rhoades-Jones, and guest speaker Jennifer Makin.

D. GUEST SPEAKER Jennifer Makin, Republic Services Recycling Coordinator Ms. Makin provided an overview of Republic Services Environmental Services program. Republic Services is responsible for the weekly curbside collection of refuse, recyclables and organics within the City of Newark. Ms. Makin informed Advisory Committee members of the three cart system which includes collection. proper cart set up, acceptable materials per container and recycling services.

> Republic Services offers discount rates for senior citizen age 70 and over, and disabled persons under the PG&E Low Income Rate Payer Assistance program.

E. **HUMAN SERVICES/SENIOR CENTER STAFF REPORT**

Recreation and Community Services Director David Zehnder distributed and reviewed with the committee a detailed report for the month of May, 2016.

Overall daily and program attendance for the month was 2,184 with no new Senior Case Management cases opened. An average of eleven (11) daily meals were served at the Senior Center and Meals on Wheel delivered a daily average of 54 meals. Volunteers clocked 425 hours of service for the month.

G. NEW BUSINESS

G.1 Fremont, Union City and Newark Joint Senior Committee Report – Woody Ballard

Committee Member Ballard shared briefly an update on the "Dementia Friendly Community program. Senior Commissioners and Committee Members from the Cities of Fremont and Union City also met to discuss the action plan for this project.

G.2 Newark Paratransit Program Update

Recreation and Community Services Director David Zehnder distributed and reviewed with the committee a detailed report for the Fiscal Year 2015 – 2016 Newark Paratransit program. He explained to committee members that the City of Newark continues to provide destination-to-destination paratransit services for Newark seniors ages 70 and over and disabled persons ages 18 and over, under a Joint Powers Agreement (JPA) with the City of Fremont Human Services.

Funding for the program is provided through voter approved Measure B and Measure BB sales tax which is administered by the Alameda County Transportation Commission.

The report highlighted year-to-date performance statistics associated with this service. Additionally, the Paratransit Advisory and Planning Committee (PAPCO) accepted the 2016-2017 Annual Program Plan Application with conditions. These conditions will be reported at the next paratransit program update. Service levels and ridership are projected to remain the same for fiscal year 2016-2017.

Committee Members R. Arellano, S. Arellano, Powell and Wickizer attended and reported on the Senior Rally Day on May 11 in Sacramento at the State Capital.
