D. HUMAN SERVICES/SENIOR CENTER STAFF REPORT

Recreation and Community Services Director David Zehnder distributed and summarized the comparison charts through April 2018 and advised Newark Paratransit numbers were now updated through March 2018. Director Zehnder provided a detailed breakdown of services including door-to-destination paratransit rides, taxi voucher rides and companion ridership. Paratransit numbers rose partly due to the start of spring and an increase in activities as a result of the warmer weather. He further reported that during the last PAPCO meeting, Newark's Paratransit plan for fiscal year 2018-2019 was unanimously approved. He also discussed a potential a subsidized Uber/Lyft program which could be available as a supplemental service for Newark and Fremont paratransit riders by this summer.
