# City Council declares the City of Newark a Welcoming City

n the last few months, the City of Newark has received Linguiries as to where the City stands on Federal actions related to immigration. Ten years ago, the City joined the National League of Cities Inclusive Communities Partnership Program. As an inclusive community, Newark promotes mutual respect and appreciation for all people represented within our community.

On February 23, 2017. the City of Newark City Council reaffirmed those values by declaring the City a Welcoming City.

# **RESOLUTION 10,598**

RESOLUTION OF THE CITY OF NEWARK DECLARING THE CITY OF NEWARK A WELCOMING CITY

WHEREAS, the City of Newark is committed to building a neighborly community that is inclusive, hospitable, and welcoming;

WHEREAS, the City of Newark seeks to help people, families, and institutions thrive and to value the contributions of all members of the community including newcomers and immigrants:

WHEREAS, the City of Newark is a diverse, multi-ethnic community that celebrates embraces its many cultures; and

WHEREAS. City the Newark is committed to continue enhancing its cultural fabric, economic success, global competiveness and overall prosperity for all those who choose to make their home in the City; and

WHEREAS, the City of Newark promotes the health, safety, and success of all; and

WHEREAS, the City of Newark promotes inclusiveness, mutual respect, and cooperation throughout the community; and

WHEREAS, the Newark Police Department, in keeping with this philosophy, does not actively participate in the enforcement of federal immigration laws, which are under the jurisdiction of the U.S. Immigration and Customs Enforcement: and

WHEREAS, the Newark Police Department, like many other police departments in California, focuses their time on responding to and investigating high-priority crimes and not the enforcement of federal immigration laws; and

WHEREAS, the Newark Police Department has no desire to undermine community trust, and deter law-abiding individuals from reporting crimes or coming forward as witnesses; and

WHEREAS, the Newark Police Department serves all members of the public equally; and

WHEREAS, for all of the foregoing reasons, the City Council of the Newark would like to declare the City of Newark a Welcoming City:

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Newark hereby declares the City of Newark a Welcoming City.

# Measure B/Measure BB and Vehicle Registration Fee funding at work in Newark

# Street maintenance

s part of the City of Newark's ongoing effort to protect and extend the life of its streets, the Public Works Department annually inspects asphalt concrete pavement surfaces to identify areas of potential maintenance and determine the timing and type of appropriate repairs. The types of preventative maintenance performed on our streets include crack filling, patch paving, and slurry seal resurfacing. For those streets in a more deteriorated state, a pavement overlay or even costlier reconstruction may be necessary.

Annual pavement overlay, patch paving, and slurry resurfacing projects are an integral part of the City's Pavement Management Program. These projects will be partially funded by Measure BB (approved by voters on November 4, 2014), which extended the Measure B sales tax until 2045. The projects will also be partially funded by the Alameda County Vehicle Registration Fee (VRF) program, a \$10 per vehicle annual registration fee approved by

voters as Measure F in 2010. These transportation funding programs are administered through the Alameda County Transportation Commission (Alameda CTC).

Pavement overlays typically involve partial or full grinding of the existing surface and placement of a new 2" to 3" layer of asphalt concrete. A completed pavement overlay results in a significant structural upgrade and provides the appearance of a brand new roadway.

Patch paving consists of the removal and replacement of localized pavement failures. The project typically includes work on streets that will be resurfaced with a slurry seal. It also includes streets where a failure is too severe to correct with a surface patch, but the entire street does not require a structural upgrade with an asphalt overlay.

Slurry seal is a thin coating of a cold mixture consisting of asphalt, oil, water, and rock that

seals and protects the pavement from the damaging effects of the sun's ultraviolet light and rain water runoff. Applying a slurry seal is comparable to the repainting of a house to protect its exterior surface. This preventative maintenance process is a costeffective measure to prolong the life of City streets and maximize the value of previous investments.

# Curb, gutter and sidewalk projects

his year, the City of Newark, in conjunction with the Alameda CTC, will also utilize Measure B/Measure BB funds for the 2017 Curb, Gutter, and Sidewalk Replacement Project. This project is coordinated with our annual concrete grinding program to address damaged concrete surfaces within the public right-of-way.

Most raised concrete issues can be corrected through periodic grinding rather than complete replacement. Only severely damaged sidewalks, curb and gutter, and driveway entrances are removed and replaced with the annual replacement project. The locations selected for replacement are prioritized based on the level of damage. Work associated with the replacement project can also include tree root pruning and root barrier installation to help prevent future damage. The concrete grinding and replacement projects together are successful in helping to maximize public safety and contributing to the City's overall aesthetic appeal.

POR CUANTO, la Ciudad de Newark está comprometida a construir una comunidad de vecinos inclusiva, hospitalaria y acogedora;

POR CUANTO, la Ciudad de Newark procura ayudar que la gente, las familias y las instituciones prosperen y aprecien las contribuciones de todos los miembros de la comunidad, incluyendo los recién llegados y los inmigrantes;

POR CUANTO, la Ciudad de Newark es una comunidad diversa y multiétnica que celebra y acoge sus varias culturas; y

POR CUANTO, la Ciudad de Newark está comprometida a seguir mejorando su tejido cultural, éxito económico, competitividad mundial y prosperidad general para todos los que elijan residir en la Ciudad; y

In November 2016, the voters of Newark approved Measure GG Lproviding for a one-half cent sales tax for the purpose of building a new civic center. The new civic center buildings will replace the current antiquated and seismically deficient facilities with a modern police operations center, world class library, vibrant public spaces, and efficient accessible City offices. All three new buildings will be state of the art and LEED certified and will be arranged on the site to provide a welcoming multi-function event space. City Council Chambers will be configured and located to provide for comfortable public meetings for not only Newark City Council but for other government agencies such as the Newark Unified School District.

The new Civic Center will be built on the current Civic Center site at the corner of Newark Boulevard and Thornton Avenue. During construction the Library, Police Department, and City Administrative offices will continue to be occupied and open to the public.

In December 2016, the City of Newark prepared and released a Request for Qualifications (RFQ) for a design architect. The City received ten submittals and interviewed three firms. The Request for Proposals (RFP) went out to two qualified firms the first week of March. It is anticipated that the architectural firm will be selected by the middle of April 2017, and the design work will begin in May 2017. It is anticipated construction will commence summer of 2018 with occupancy occurring in the Summer/Fall of 2020.
