E.2 Revised Disaster Council Ordinance – Becker

- In November 2017 Newark City Council approved revisions.

E.3 Disaster Service Worker Resolution – Becker

- City Disaster Service Worker Resolution State Compensation approved by Newark City Council in November 2017.
- The Disaster Council Ordinance and Disaster Service Worker Resolution will be sent to State OES after the second reading occurs at the December 14 City Council Meeting.

E.4 Review of CERT Academy Classes – Libby

- CERT Academy Classes approved by Council for 2018 as follows:
 - 1. The California Earthquake Authority
 - 2. P.G.&E.
 - 3. Pets in a disaster
 - 4. Disability Preparedness
 - *These are supplemental training courses and do not qualify under FEMA guidelines for CERT graduation.
- The first CERT class is to be held in March of 2018.
- CERT class schedule is as follows:
 - 1. Emergency Preparedness
 - 2. Fire Safety, Utility Control and Hazardous Materials
 - 3. Disaster Medical Operations
 - 4. Light Search and Rescue
 - 5. CERT Organization
 - 6. Disaster Psychology
 - 7. CERT and Terrorism

E.5 TESA Revamp – Libby

- The name TESA has been changed to Tri-City Emergency Coalition
- The next Tri-City Emergency Coalition meeting will be held at the Alameda County Water District office in Fremont on January 9, 2018 at noon.
- The purpose of these Emergency Coalition meetings is to have all organizations communicating their needs in case of a disaster.
- The last Tri-City Emergency Coalition meeting was held on November 7, 2017 and participation was good but more involvement from organizations is expected going forward.

E.6 HAM Radio Access – Mike (Late Addition)

- HAM radio is located at Alameda County Fire Department station #28 in Newark.
- The HAM radio is routinely used, exercised and examined to make sure every function on the radio works accordingly.

- The City of Newark has been assigned "leadership role" every 3 months in organizing a radio check with key emergency organizations.
- These weekly checks have found and corrected issues within the HAM radio, keeping it in great working order if needed.
