Thursday, November 12, 2020

A. ROLL CALL

Mayor Nagy called the meeting to order at 7:05 p.m. Present were Council Members Hannon, Collazo, Freitas, and Bucci. All participated via virtual teleconference.

RESOLUTION NO. 11140

Senior Civil Engineer Cangco stated that Tract 8459 is a 138-unit residential development located to the west of Willow Street between Enterprise Drive and Seawind Way. If a majority protest does not exist, Council may consider approving the annexation.

Council Member Bucci moved, Council Member Collazo seconded to by resolution, support authorizing the assignment of: up to \$5,426,348 of Measure A1 Base City to Eden Housing for development of a 79 unit senior affordable housing development located at 37660 Timber Street. The motion passed, 5 AYES.
