A. ROLL CALL

Mayor Nagy called the meeting to order at 7:00 p.m. Present were Council Members Hannon, Collazo, Freitas, and Vice Mayor Bucci.

B. PRESENTATIONS

F. OTHER BUSINESS

1. Adopt a resolution approving the 2021-2023 Affordable Housing Work Plan Resolution No. 11201

Community Development Director Turner and Paul Peninger of Baird and Driskell Community Planning gave the presentation recommending approval. (Presentation on file with City Clerk.)

Mayor Nagy stated that the charts show housing units allocated but do not show approved units that have not been occupied or begun construction.

Council Member Collazo asked if there were nonprofits who helped landowners develop their land for affordable housing. Mr. Peninger stated he would research and follow up with her, but did not think nonprofits would assist in development projects of less than half an acre.

Council Member Hannon requested the following: 1. add a column to the chart showing what has been approved and planned to be built in the future, 2. Add a footnote to the Regional Housing Needs Assessment Chart defining moderate income; 3. Survey of surrounding communities on their affordable housing fees; and 4. Ensure bilingual information is provided for the stakeholder meetings, including a presentation in Spanish.

No one from the public requested to speak.

Council Member Hannon moved, Council Member Collazo seconded, to adopt a resolution approving the 2021-2023 Affordable Housing Work Plan. The motion passed, 5 AYES.

G. CITY COUNCIL MATTERS

The entire City Council commended Mayor Nagy on the virtual State of the City address.

Vice Mayor Bucci stated that the recreational swimming would open, by reservation, at the Silliman Center beginning Memorial Day weekend. He commended Community Development Director Turner on the Affordable Housing Work Plan.

Council Member Hannon commended City Manager Benoun and City staff, noting that pay raises were eliminated to help offset the City's deficit.

Council Member Collazo stated that she toured the new police station, and it is a state of the art facility. Shop Newark.

Mayor Nagy thanked Assistant to the City Manager Laurie Gebhard for her work on the State of the City address.
