A. ROLL CALL

Mayor Nagy called the meeting to order at 7:05 p.m. Present were Council Members Hannon, Collazo, Freitas, and Bucci.

B. PRESENTATIONS

1. Proclaiming June as Elder Abuse Awareness Month

Mayor Nagy presented the proclamation to Deputy District Attorney Cheryl Poncini and Charmaine Brent, Lead Regional Supervisor from Ombudsman Services of Contra Costa, Solano, and Alameda.

2. Proclaiming June as LGBTQ Pride Month

Mayor Nagy presented the proclamation to Recreation Supervisor Nick Cuevas.

Council Member Hannon requested that staff review the Silliman Center family passes and consider reducing the fees for families that live in Newark and qualify under the CARES Act

Mayor Nagy requested that staff review all recreation programs (not just family passes) and consider fee reductions for Newark residents that qualify under the CARES Act.

Council Member Hannon moved, Council Member Collazo seconded, to approve, via resolution, amending the Master Fee Schedule for fiscal year 2021-2022 with direction to staff to re-examine the recreations fees that are charged to families and individuals that may qualify for reduction based on their qualification for the CARES Act, and return to the City Council in July, if possible. The motion passed 5 AYES.

G. CITY COUNCIL MATTERS

Mayor Nagy stated that Safe and Sane fireworks are only allowed on the Fourth of July. He requested that people stop using illegal fireworks.

Vice Mayor Bucci stated that the City Council was invited to attend the Newark Memorial High School graduation. He thanked everyone who made the in-person graduation possible and congratulated the graduates.

Council Member Hannon agreed with previous comments. He encouraged people to volunteer their time for the community.

Council Member Collazo agreed with the previous comments. She noted that Safe and Sane fireworks are a fundraiser for nonprofits, the use of illegal fireworks could ruin that. In reference to the Elder Abuse Awareness Month Proclamation, she encouraged reporting suspected abuse. Shop Newark.
