A. ROLL CALL

Mayor Nagy called the meeting to order at 7:04 p.m. Present were Council Members Hannon, Collazo, Freitas, and Bucci.

B. PRESENTATIONS

C. PUBLIC COMMENT

Mary Paglieri speaking on behalf of the Citizen Coalition for a Fireworks Free Newark, stated that legal fireworks should be banned for public safety. They pose serious health risks to people and animals. Community nonprofits could use other forms of fund raising. She requested that the City Council place fireworks on the City Council agenda for discussion after the Fourth of July.

D. CONSENT CALENDAR

Council Member Hannon and City Manager Benoun requested the removal of item F.10 for separate discussion.

Council Member Collazo moved, Council Member Bucci seconded, to approve Consent Calendar Items D.1 through D.9, that the resolutions be numbered consecutively, and that reading of the titles suffice for adoption of the resolutions. The motion passed, 5 AYES.

Adopt a Resolution Approving and Authorizing the City Manager to Execute a Lease with Alameda County for the Alan L. Nagy Library Resolution No. 11220 Contract No. 21030

Council Member Hannon asked when the library would open. City Manager Benoun stated that he did not anticipate it opening for several months. The County of Alameda needs to acquire bookshelves, other materials, and to execute a lease with the City.

Council Member Hannon stated that after the City budget improves, he would like the City Council to consider funding Sunday hours at the library.

City Manager Benoun stated that after the posting of the agenda, staff learned that the County may request that the City acquire certain materials to be installed in the library with the County reimbursing the expenses. He requested that the resolution be amended to allow staff to revise the lease agreement for this purpose.

Assistant City Manager Hovorka shared her screen with the proposed revisions to the resolution. The last paragraph would be:

"BE IT FURTHER RESOLVED that the City Manager is authorized to take any actions necessary to effectuate the intent of this Resolution, and make any non-substantive revisions to the Lease Agreement, and make any revisions to the Lease Agreement to include any additional work to prepare the Alan L. Nagy Library for occupancy for which the City will be fully reimbursed, subject to approval of the City Attorney as to form."

Council Member Hannon requested that City Manager Benoun report the changes made to the Council Members. He also suggested that City Council consider increasing the City Manager's authorization limit for reimbursement matters in the future.

No one from the public requested to speak.

Council Member Hannon moved, Council Member Collazo seconded to approve the resolution, as revised, authorizing the City Manager to execute a lease agreement with County of Alameda for library services. The motion passed 5 AYES.

E. PUBLIC HEARINGS

City Manager Benoun stated that due to property ownership within Landscaping and Lighting Districts 10 and 11, Council Member Collazo will recuse from public hearings E.12 and E.13 and he will recuse from hearing E.13. He suggested that the City Council consider public hearings E.1-E.11 concurrently. The City Council agreed with this suggestion. He gave the staff report recommending approval.

Council Member Bucci moved, Council Member Hannon seconded to, to approve the diagram and assessment and levy the annual assessment for Landscaping and Lighting District Nos. 10 and 11 for the 2021-2022 fiscal year. The motion passed, 4 AYES, 1 RECUSED (Collazo).

Council Member Collazo and City Manager Benoun returned to the City Council meeting.

F. OTHER BUSINESS

 Adopt a Resolution authorizing a one-time exception to the systematic decrease in the maximum allowable number of safe and sane fireworks booths permits due to global supply chain shortages Resolution No. 11234

City Manager Benoun gave the staff report recommending approval. Nonprofits that choose not to operate a fireworks booth this year would still be allowed to request a permit next year.

In response to Council Member Hannon, City Manager Benoun stated that at least one nonprofit would like the one-time exception.

No one requested to speak.

Council Member Bucci moved, Council Member Collazo seconded to approve a resolution authorizing a one-time exception to the systematic decrease in the maximum allowable numbers of safe and sane fireworks booths due to global supply chain shortages. The motion passed, 5 AYES.

Finance Director Lee gave the staff report recommending approval. (Presentation on file with City Clerk).

Council Member Hannon requested that in the future, the tables have a column with anticipated numbers for the next fiscal year for a comprehensive review of the budget.

Council Member Collazo moved, Council Member Hannon seconded to approve a resolution amending the 2020-2022 Biennial Budget and Capital Improvement plan for Fiscal Year 2021. The motion passed 5 AYES.

G. CITY COUNCIL MATTERS

Mayor Nagy stated that he would adjourn the meeting in memory of Vivien Larsen. The entire City Council extended their condolences to the Larsen family.

Mayor Nagy stated that only Safe and Sane Fireworks are allowed on the Fourth of July.

Council Member Hannon wished his wife Kathleen a happy 43rd wedding anniversary.

Council Member Freitas requested that people be careful with their Safe and Sane fireworks on the Fourth of July.

Council Member Collazo congratulated Administrative Assistant/Marketing Coordinator Edda Rivera who was named Employee of the Year at the Employee Service Awards. She stated that it is difficult to catch people using illegal fireworks and that communities that have banned fireworks have the same issues. She stated that she anticipates the fireworks booths selling out early due to the Safe and Sane Fireworks shortage. Shop Newark.

Council Member Bucci congratulated Ms. Rivera and wished everyone a safe Fourth of July.
