A. ROLL CALL

In response to his question about Thornton Avenue, Public Works Director Fajeau stated that staff applied for federal funds to repave Thornton Avenue from Interstate 880 to Olive Street.

Mayor Hannon stated that he presented a Dr. Martin Luther King, Jr. Day proclamation for the Afro-American Cultural and Historical Society's annual Dr. King commemoration program.
