Minutes

Thursday, May 25, 2023 7:00 P.M.

A. ROLL CALL

Mayor Hannon called the meeting to order at 7:00 p.m. Vice Mayor Collazo, Council Members Bucci, Freitas, and Jorgens were present.

B. PRESENTATIONS

Mayor Hannon introduced Dr. Penelope DeLeon who was recently selected as the Superintendent for the Newark Unified School District.

Mayor Hannon presented a commendation to Stephanie Schubert for her Teacher of the Year achievement.

c. PUBLIC COMMENT

No one requested to speak.

D. CONSENT CALENDAR

Vice Mayor Collazo moved, Council Member Freitas seconded, to approve Consent Calendar Items D.1 through D6, that the resolutions and ordinances be numbered consecutively, and that reading of the titles suffice for adoption. The motion passed, 5 AYES.

Rose Kane requested that the weed abatement procedures not harm the wildlife on the lot at Willow Street and Enterprise Drive.

Mayor Hannon closed the public hearing at 7: 22 p.m.

Council Member Bucci moved, Vice Mayor Collazo seconded, to act upon any objections by property owners to the 2023 Weed Abatement Program, and instruct the Superintendent of Streets to abate the public nuisances. The motion passed, 5 AYES.

The motion passed, 5 AYES.

F. OTHER BUSINESS

Council Member Bucci requested that the Newark Bucks funding exercise be used again for the public meetings.

Council Member Bucci moved, Vice Mayor Collazo seconded, to adopt a resolution authorizing the City Manager to execute a contractual services agreement with RHAA Landscape Architecture & Planning and Authorizing an Amendment of the 2022-2024 Biennial Budget and Capital Improvement Plan for Fiscal Year 2023 to provide funding for the citywide parks master plan update. The motion passed, 5 AYES.

2. Adopt a resolution approving an exception to the 180-day wait period for the post-retirement employment of Joella Kapu as an extra-help rehired annuitant Public Safety Dispatcher Resolution No. 11508

Human Resources Director Solito gave the staff report recommending approval.

Council Member Freitas moved, Council Member Bucci seconded, to adopt a resolution approving an exception to the 180 day wait period for the post-retirement employment of Joella Kapu as an extra-help rehired annuitant dispatcher. The motion passed, 5 AYES.

G. CITY COUNCIL MATTERS

Council Member Jorgens stated that he attended the Newark Memorial High School (NMHS) Senior Awards Night and congratulated the Class of 2023. He announced that his brothers, Tyler and Scott, were each named Coaches of the Year for NMHS.

Council Member Bucci thanked City staff for their help for the Community Swearing-In of Supervisor Elisa Márquez. He congratulated Teacher of the Year Stephanie Schubert.

Vice Mayor Collazo stated it was Memorial Day weekend and honored those who had fallen in service to the country. She stated that Bear Bitez was listed as a top burger restaurant and looked forward to trying it. Shop Newark

Mayor Hannon congratulated Betty Gentry Dance Group for the 60th dance review. He announced that Fitch Ratings has reaffirmed that the city's financial outlook is stable and reissued an AA+ credit rating. He congratulated Finance Director Lee and her staff. In honor of Memorial Day, he read a poem by William T. Elliot on the Vietnam War.

City Manager Benoun stated that the Broadband Master Plan survey would be available online for the public to fill out over the next 6 weeks and community meetings would be held.
