Thursday, June 22, 2023 7:00 P.M.

A. ROLL CALL

Mayor Hannon called the meeting to order at 7:00 p.m. Vice Mayor Collazo, Council Members Freitas, and Jorgens were present. Council Member Bucci was noted absent.

c. PUBLIC COMMENT

Milind Shyani stated that he and his wife recently moved to the city of Newark and noted the lack of trees on Newark Boulevard after Cedar Boulevard. He requested additional trees be planted.
