Community Development Impact Fees

Effective September 25, 2023

WHAT IS AN IMPACT FEE?

An **impact fee** is a fee that is imposed by a local agency on a new or proposed development project to help pay for all or a portion of the costs of providing public services to the new development. Impact fees are considered to be a charge on new development to help fund and pay for the construction or needed expansion of offsite capital improvements.

The following is a list of current impact fees:

1. Park Impact

a. Projects w/o Dedicated Land

Single-Family: \$31,130.44/unit Multi-Family: \$22,414.32/unit

b. Projects w/ Dedicated Land

Single-Family: \$9,339.13/unit Multi-Family: \$6,599.69/unit

2. Capital Facilities

a. Public Safety

Single-Family Residential: \$4,298.00/unit
Townhome: \$4,298.00/unit
Multi-Family Residential: \$2,578.59/unit
Office/Commercial: \$0.75/sq.ft.
Manufacturing/R&D: \$0.32/sq.ft.
Warehousing/Distribution: \$0.62/sq.ft.

b. Community Service/Facilities

Single-Family Residential: \$2,877.89/unit
Townhome: \$2,877.89/unit
Multi-Family Residential: \$1,439.45/unit
Office/Commercial: \$1.07/sq.ft.
Manufacturing/R&D: \$0.23/sq.ft.
Warehousing/Distribution: \$0.45/sq. ft.

c. Transportation

Single-Family Residential: \$6,193.51/unit
Townhome: \$3,219.93/unit
Multi-Family Residential: \$3,839.90/unit
Commercial: \$5.49/sq.ft.
Manufacturing: \$3.00/sq.ft.
Distribution: \$6.00/sq.ft.

3. Housing

a. Residential

First 1,000 sq.ft./unit*: \$24.95/sq.ft.

All sq.ft. over 1,000 sq.ft./unit:

\$10.00/sq.ft.

*No fee for first 200 sq.ft. of a residential addition

b. <u>Non-Residential</u>

Commercial: \$4.48/sq.ft. Industrial: \$0.84/sq.ft.

4. Art in Public Places and Private Development

Residential (excluding affordable housing):

\$270.00/unit

Retail: \$0.26/sq.ft.
Office: \$0.38/sq.ft.

Light Manufacturing/Warehouse:

\$0.21/sq.ft.

High-Tech: \$0.41/sq.ft.

5. Community Development Maintenance Fee

0.5% of construction valuation
