A. ROLL CALL

Mayor Hannon called the meeting to order at 7:03 p.m. Vice Mayor Collazo, Council Members Bucci, Freitas, and Jorgens were present.

Council Member Jorgens stated that the grants with the State of California did not impact the office of his employer, a State Assembly Member.

City Manager Benoun gave the staff report recommending approval.

Council Member Bucci thanked Assembly Member Alex Lee for his assistance in acquiring the grants. He stated that the Broadband Community meeting will be held on August 25, 2023 at 2 pm.

Moved by Council Member Bucci, seconded by Council Member Jorgens to adopt a resolution. The motion passed 4 AYES, 1 RECUSED.

Council Member Freitas returned to the City Council Chambers.

E. PUBLIC HEARINGS

City Manager Benoun stated that the Master Fee Schedule was undergoing a comprehensive review and would be presented to the City Council at a future meeting. He recommended increases to the Development Impact Fees based on the Engineering News Record Cost Construction Index.

City Attorney Kokotaylo gave the staff report recommending approval.

Council Member Bucci stated City Manager Benoun has done a great job.

Vice Mayor Collazo thanked City Manager Benoun for his round the clock service.

Mayor Hannon stated that City Manager Benoun is an outstanding leader.

Moved by Council Member Bucci, seconded by Vice Mayor Collazo to adopt a resolution. The motion passed, 5 AYES.

G. CITY COUNCIL MATTERS

Council Member Bucci welcomed Officer Bun. He announced that Super Mario Brothers would play for Movie Night at the Community Center on Saturday. He stated that his friend Griffin Daily, announced his colon cancer diagnosis and he recommended that anyone 45 or older get screened.

Vice Mayor Collazo recommended people stay up to date on pneumonia vaccines and shared her experience with pneumonia. She welcomed Officer Bun. She noted that the city of Vallejo Police Department was understaffed and she felt safe here. She announced that OMT and Tortilla Soup would perform at Groovin at the Grove. Shop Newark.

Council Member Freitas stated that the Volunteer Recognition Ceremony was held last week. He thanked all of the volunteers for their service. He thanked City Manager Benoun for his service and noted that with 4 ½ years of service, he was one of the senior city managers in Alameda County.

Mayor Hannon congratulated Vice Mayor Collazo for the Mariachi Festival success. The Newark Optimist Club is hosting a garage sale this Saturday to benefit Relay for Life. The City Council holds an August Recess and will not meet again until September. September is the city of Newark's birthday.

H. CITY MANAGER UPDATES

City Manager Benoun stated that August 1 is National Night Out and Newark Days begins on September 14.

Assistant City Manager Hovorka stated that the Parks Master Plan and the Active Transportation Plan Updates will have a table at the Newark Days Community Information Faire. The Broadband Masterplan online survey was reopened until August 21. A Pop-up Recreation event will be held at Birch Grove Park on August 3 and a Family Fun Run at Lakeshore Park on August 18.
